("WINNEBAGO"), THE UNDERSIGNED HEREBY AGREES TO FULLY RELEASE, DISCHARGE AND HOLD HARMLESS WINNEBAGO FROM ANY LIABILITY FOR ANY DAMAGES, INJURIES, LOSSES OR CLAIMS, INCLUDING ANY INJURIES OR DAMAGES TO THE UNDERSIGNED OR OTHER PERSON OR PROPERTY, AS A RESULT OF THE UNDERSIGNED'S PRESENCE ON WINNEBAGO'S PROPERTY, EXCEPT TO THE EXTENT DUE TO WINNEBAGO'S GROSS NEGLIGENCE OR WILLFUL MISCONDUCT. The undersigned understands that this is a contract, which limits the undersigned's legal rights, and it is binding upon the undersigned and his or her heirs, agents and legal representatives. If portions of this Liability Release are found invalid or unenforceable, it is agreed that the remaining portions will remain intact and enforceable, and the invalid or unenforceable provision will be deemed replaced with a valid and enforceable provision that most closely resembles the parties' original intent. This Liability Release shall be governed by the laws of the State of Iowa, regardless of any conflicts of laws principles.
